

Kelly's Photography - Wedding Contract

This Contract will serve as an order for photographic services by Kelly's photography, known hereafter as KP. At the time of signing by the photographer and client(s), the date of the wedding shall be reserved and KP will make no other reservations for the date.

All parties will recognize the items listed in this contract as legal and binding. No item(s) shall be modified unless agreed upon by the contracting party and KP. This contract will be considered void if altered without consent of KP.

Contracted services shall include the following:

Terms of Contract

1. All Photographs taken by KP or a representative of KP will remain the property of KP. All photographs created are protected by the United States Copyright Laws (USC title 17) and shall not be reproduced in any manner without the written consent of KP.
2. Any and all photographs taken by KP may be considered for use on promotional materials such as on-line web portfolio, studio portfolio or brochures of and for KP. For this purpose, this contract shall also serve as a model release.
3. No photographs of your wedding will be sold by KP to anyone except the Bride and Groom or their representative. By giving your consent, you are thereby giving consent and permission for said person to order photos of your wedding.
4. Each client can receive two sets of full resolution digital files. These files are for personal printing only and cannot be entered into contests or used for commercial purpose as outlined in the digital file form.
5. Each client shall receive a written shared copyright release that grants permission for the photographs to be printed, displayed to otherwise use in a prudent manner for personal use, No permission is granted in the copyright allowing for the usage of included photographs for commercial or contest purposed.
6. Kelly's Photography warrants that the files on the CD/DVDs are high-resolution files that have been adjusted for color and tone only.
7. Kelly's Photography is not responsible for the quality of any prints that are not from Kelly's Photography.
8. No other photographer, professional or amateur, shall be permitted to photograph during the time that KP or representative of KP is photographing posed formals.
9. It will be the responsibility of a member of the wedding party, or their designate to ensure that all guests adhere to this policy.
10. Kelly's Photography accepts no responsibility for the results of another person's flash on their photography.

11. Every effort will be made by KP to protect the digital files photographs of your wedding, In the event of damage, including loss or complete destruction, KP limits responsibility to the refunding of all retainers and deposits.

12. Requested pictures will be given every reasonable effort to be taken, Due to the fast paced mature of wedding photography KP will not promise any particular shot, When possible, all photographs requested by the Bride and Groom will be taken.

13. Due to the limitations of some wedding venues Flash Photography may not be permitted. All efforts will be taken to get the best Portraits possible.

14. Upon signing of this contract/day of booking, a non-refundable retainer of \$250 is due; the next payment of 1/2 the balance is due no later that 30 day's prior to your wedding. The remaining 1/2 is due the day of the Wedding.

15. Failure to remit payment will result in cancellation of this contract and forfeiture of retainer and any other payments made at such time.

16. You will be notified, within three weeks, when your proofs are ready the viewing.

17. All parties, including Bride and Groom and KP or representative of KP, must sign this contract in duplicate.

18. Failure to follow any item or part of it, listed in this contract will serve as just reason for KP to cancel the request for photographic services and will cause the forfeiture of retainer and all other payments received.
